

# **Community Heritage Grant Fund**

# **Guidelines and Conditions**

#### 1.0 BACKGROUND

The Trustees of Perth and Kinross Heritage Trust initially designated £65,000 towards a Community Heritage Grant Fund in 2021 to support community projects which conserve or enhance the historic environment within Perth and Kinross. This followed a successful pilot scheme in 2020. To date they have committed over £70,000 towards local heritage initiatives but with a further £70,000 available in the fund, they hope to support many more projects over the next couple of years.

Eligible projects will be for:

- Conservation of historic buildings or monuments in Perth and Kinross that have established and generally unhindered public access.
- Community based recording, research and interpretation of the historic environment in Perth and Kinross

## 2.0 GRANT RATES AND APPLICATION DATES

- 2.1 Grants of up to £5,000 will usually be available per project, but, exceptionally, larger sums may be considered by Trustees. Trustees may also consider an intervention rate of up to 100% in exceptional circumstances, but priority will be given to projects where there is some match funding. A minimum in-kind contribution equivalent to the grant will be expected and may include commitments of time, materials, land or buildings etc which should all be valued at a reasonable rate.
- 2.2 Applications should be made by completion of a Community Heritage Grant application form and will be grouped and formally assessed by the Trust on a quarterly basis: 1 March, 1 June, 1 September, and 1 December. You may be contacted for further information or an assessment visit before a decision is made. The Trust will aim to complete the assessment of your application and notify you of a decision within 2 months.
- 2.3 The Trust may not commit the full fund if insufficient appropriate applications are received and reserve the right to review and change the eligibility criteria and operation of the fund should circumstances make it necessary. Grant offers will be entirely at the discretion of the Trust.

# 3.0 IS YOUR PROJECT ELIGIBLE?

Successful applications are likely to:

- 3.1 Be from constituted community organisations with a bank account; applications from private owners may be considered for conservation work if the project has no obvious personal commercial benefit and a clear community benefit; projects are not likely to be for domestic or commercial properties.
- **3.2** Be from groups with a local focus and preference will be given to projects out with Perth City.
- 3.3 Be unable to access significant grant funds from other funders and will not be eligible for assistance from the Perth City Heritage Fund.

- 3.4 Be not for consultant fees alone, but special consideration will be given to early interventions such as Options Appraisals, Viability Studies and Condition Surveys for empty buildings in Perth and Kinross where the project is also being supported by the Architectural Heritage Fund's Project Viability Grant programme and otherwise meets our geographical and ownership criteria.
- **3.5** Follow current conservation or archaeological best practice and include a conservation statement where appropriate.
- 3.6 Include a clear plan for the ongoing maintenance, care and management of any physical assets involved in the project, or public dissemination of any recording or research.
- 3.7 Demonstrate how the project preserves, enhances and increases understanding of Perth and Kinross's historic environment; improves the condition and the use of the historic environment to create economic and social benefit; and promotes good management of the historic environment.

Applicants should contact PKHT as early as possible in a project's development to ensure eligibility of the proposed works.

#### 4.0 HOW TO APPLY

Send a completed Community Heritage Grant application form and any requested supporting information to PKHT at the address below. We recommend you contact PKHT to discuss your project more generally before submitting an application form. In certain circumstances, PKHT staff may be able to offer support to you to develop your project and application.

#### 5.0 SUMMARY OF PRINCIPLE GRANT CONDITIONS

- 5.1 If approved, a formal written offer of grant will be made subject to the general conditions contained within these guidelines and specific conditions in relation to the individual project. Works must not commence before written notification of the outcome of the grant application has been received from PKHT and accepted in writing. Retrospective applications for grant assistance to works already underway or completed will not be considered.
- 5.2 Payment of the grant is made on the completion of all works to the satisfaction of PKHT and following the submission of a claim, in writing, supported by receipted invoices or other evidence of the costs incurred and a maintenance plan. Interim payments of grant may be considered.
- 5.3 If the final cost of the works is lower than expected, PKHT will reduce its contribution pro-rata. Any changes to the project without prior agreement from PKHT may reduce or terminate the grant offer.
- 5.4 The grantee is responsible for ensuring, and may be required to provide evidence that, all statutory and regulatory consents and approvals required for the project are in place.
- **5.5** Grant offers are usually open for acceptance for two months and, if not accepted in writing, will automatically be withdrawn.
- Works must be completed, and the final claim for grant made, within one year of the offer unless previously agreed in writing or the grant will be withdrawn.
- 5.7 A PKHT contribution towards a project must be acknowledged by the applicant during and after the works, in all reports and publicity connected with the project, including website and social media.

- **5.8** PKHT reserves the right to publicise in its Annual Report, and elsewhere, information relating to any project which it has supported.
- **5.9** Significant and, usually, unrestricted public access is a condition of grant.
- **5.10** Grant may be recovered at any time if any condition of grant is not complied with.
- **5.11** Owners of property may be required to agree to a Conservation Burden as a condition of grant. Related legal costs may be covered by this fund.

## 6.0 PERSONAL DATA

- 6.1 In submitting a grant application, you or your nominated representative, has acknowledged and consented that your personal data may be used by PKHT for the legitimate interest purpose of processing this application and subsequently managing a grant.
